Actually I would like to see the sources. I have a direct quote where the father says he (not BYU) provided the information to his son via email and his son made the decision. The other sources either skip who spoke with Riley altogether or paraphrase to say BYU emailed Riley. I'll take a direct quote over paraphrasing any day.

There is a big difference between the family showing interest in a University and being able to decide if they want to let their son know he can play at BYU, and contacting the kid directly. As an analogy, a missionary would much rather get a letter from a girl, then to have his father say "so-and-so says hi."

You can tell that the way BYU worked through the family with Bradley, and I suspect with Nelson, is not recruiting because NO recruiter would leave the communication of an offer entirely up to the family. The way BYU has worked through the family gives the family control over the "interruption" an offer might cause a missionary. You might not think that is significant difference, but I do. The kid has NO pressure to respond to BYU where he might be getting all kinds of letters and pressure from another school.

In sum, if BYU directly contacted this kid, even with the blessing of the family, and the family initiating contact with the coaches, then Bronco IS recruiting when he said he wouldn't do that to missionaries. How would that be any different than a father sending in highlight tapes of his kid and then BYU coaches contacting the kid?

In my mind it is not the same thing where the family does the contacting of the kid since the family has control over the communication. But, reasonable minds can differ.

I think the concesus is that there are two stories going and the one that seems more credible is the one of the dad making the initial contact after finding out that BYU would be interested in his son's services. As for all your other sources, what are their sources? They probably rely on the same source and therefore all come to the same conclusion.

As for the recruiting part, it would be silly to propose that BYU could no longer talk to coaches if they have a non-byu player serving a mission or from discussing any non-byu missionaries with head coaches. If they want to recruit the player when they get off their mission do you propose that they should not ask pertanent questions of the players head coach until the missionary is back from his mission? I think it happened much as McGregor described.

I would also add that you have two examples of missionaries to pull from. Bradley and Te'o. In both cases BYU did not make the initial contact with the family. They were given an opportunity to express their interest and both resulted in BYU saying they would offer a scholarship to both players but they did not call or write the players on their missions to recruit them. In both cases they let the families decide how they wanted to handle the offer. In both cases the families decided to let the player know and let them decide at that time instead of waiting to break the news when they got off their missions. Nothing underhanded there that I can see. And what parent wouldn't want to break news like that to their son immediately?

In fact, when BYU's Austin Collie was supposedly being recruited by other schools while still serving his mission nearly two years ago, Mendenhall acknowledged that the Cougars do sometimes contact recruitable players from other Division I-A programs who are serving missions - but only rarely, and only after "strong recommendations from their parents that they have an interest" in BYU. "We don't go looking for them," he said at the time. That seems to have been the case with Nelson.

Further:

In years past, coaches such as Utah's Ron McBride and BYU's LaVell Edwards abided an "unwritten rule" not to recruit one another's mission-serving players, but that guideline has eroded somewhat recently, other coaches have said, particularly as coaches outside Utah have sought to lure highly regarded Mormon players. When that apparently happened with Collie in 2006, Mendenhall expressed disappointment, saying that "it is a shame" that rival schools "don't see the big picture."

It seems apparent that when Bronco said BYU does not "recruit" missionaries, that he was referring to the process of identifying and actively seeking out and persuading young men who are currently serving missions. This would, for example, including getting a scouting report on a missionary and send him a letter, DVD, marketing materials, etc. extolling the benefits of BYU football, and suggesting that BYU would be prepared to offer him a scholarship. Many other schools (including the Utes) do this. Of course, one could read the term "recruit" as broadly as possible, and interpret that to include any contact whatsoever with missionaries, irrespective of who initiated it.
